#### Assessment, progression and award

- 3. All Level 4 modules must be passed with a mark of at least 50%. Additionally, in order to progress to the doctoral thesis stage, candidates must obtain an overall average mark of at least 60% in the assessment of those modules, after resits if necessary.
- 4. Before proceeding to Research Design Workshop (Level 5), candidates are required to have passed all the preceding Level 4 modules, to the value of 120 credits. Candidates who fail to fulfil this requirement will be reassessed in the failed module(s) at the next available opportunity, as determined by the Board of Examiners, and only allowed to proceed to Research Design Workshop (Level 5) upon successful completion of the reassessment.
- 5. Before proceeding to the doctoral thesis stage, candidates are normally required (subject to any exercise of discretion, in accordance with the Core Regulations for Professional Doctorates) to have passed Research Design Workshop (Level 5), which is assessed on a pass/fail basis. A candidate who fails to fulfil this requirement has the right of resubmission.
